- Finance Committee Report
 - Review August Financials
 - Review Audit Draft

CS walked the Board through the August financials, and there was a brief discussion about student enrollment, October count, and outstanding fundraising needs. The draft audit report was only just received, so advance review by the finance committee and discussion was not possible at this meeting. The board will discuss the audit in more detail at the next meeting.

- Fundraising Committee Report
 - Grant updates

MM reported that 5280 just received three significant grants/loans, including a \$40K grant from the Gates Foundation, a \$25K grant from Governor Polis' COVID fund, and a \$600K loan from Colorado Facilities Solutions.

- Executive Director Report
 - Monthly report

The school is slightly below where we expected to be on enrollment and attendance. Attendance is tricky to measure given new circumstances, students sporadically "attending virtually", and shifting enrollment; MM should have a much better sense of where we're realistically at with attendance next month. There have been no behavior incidents this year, and the school is drug free thus far—this is a big improvement compared to last year. School leadership is implementing a really focused PD plan as well, and MM reports that they are seeing positive changes thus far.

• Update on 1200 W Mississippi

There have been some challenges with the permits, (e.g., due to requests from Denver Water), which will cause delays. But ultimately, things are moving along and the space looks really good.

- Executive Committee Report
 - Update on Financial Notice of Concern

The Board discussed the notice of concern from DPS. Lori is working on a response for MM and CS to review before submitting to DPS.

• Update on annual board retreat

BR and MM to circulate draft agenda in the next few days. The retreat will be held Saturday, 9/26/20, 9am-1pm.
