

3.0 ACTION ITEMS

- Approval of Submitted Waiver Requests for DPS Policy IKF Discussed Waiver Request for DPS Policy on Graduation, starting in grad. Year2027. All agreed with MM's waiver request submitted to DPS
- [First Reading]: Approval of FY24 Initial Budget
 Budget showing 60days cash on hand; expenditures higher due to jump in salaries (7% increase);
 Total expenditures = \$2.7 million; (budgeted for 109 students current enrollment = 110). Will review again and vote on this during May Regular Mtg.

4.0 INFORMATION ITEMS

Finance Committee Report

Paul Scudo and Melissa Mouton reported on March 2023 Financials Revenues are at 77% and expenses at 56%; level of unrestricted funds look good and not a lot of liabilities

- Fundraising Committee Report
 C. O'Connell and MM met and reported: Only 1 of 3 BHA grant approved to date; one denied. 3rd
 BHA grant approval is needed to go forward with expansion. However, the Commissioner of BHA was terminated, so there is a lot of uncertainty. M.Mouton currently looking into alternative sources of funding (federal grants and state Opioid funds).
- Governance Committee Report
 - Director to manage the annual Executive Director evaluation. Discuss process of the Exec. Dir. Eval. Art Bowman agreed to oversee this.
- Executive Director Report
 - FY23 Budget Snapshot
 - Q3 Progress Report on Annual Goals M.Mouton reviewed Annual Goals decided on last year and reviewed progress toward these. Currently 3 bus routes are underway and Keith's Altitude organization will start soon. These efforts will help increase student population at 5280. Progress deemed positive.

P. Scudo made a motion and C.O'Connell seconded to enter into Executive session for the purpose of discussing the purchase, sale, or lease of a property for school expansion.
