1.0 COMMENTS

Reading of 5280 High School Mission: Through authentic academic experiences and a culture of holistic wellness embedded in strong diverse community, 5280 High School prepares all students for success in college, their future career, and anything that life throws at them.

2.0 CONSENT ITEMS

Approve March 17, 2022 Regular Meeting Minutes

Paul Scudo made a motion to approve and Cassandra Stevenson seconded the motion. The meeting minutes of the March 17th meeting were unanimously approved.

3.0 ACTION ITEMS

1st Reading: Approval of 2022-2023 Budget

Discussed FY23 budget :

- PPR is expected to jump to 5%.
- Expenses: Salary was a big jump from last year. Gave COL increase to all 5%. Hiring a Vice Principal instead of a guidance counselor which will require a higher salary, but adds more flexibility. Instead of two sobriety coaches, will bring in two more experienced counselors. Also working to hire teachers now so that will not have to spend more by hring in August like last year when the math teacher left suddenly. Contingency is at \$42k, 2%.
- Facility costs have dropped to 11% (!) which balancing out hiring of teachers.

4.0 INFORMATION ITEMS

• Finance Committee Report

C. Stevenson led this discussion:

- -Total revenue for March was \$167K. Revenues were largely in line with budget.
- Total expenses for the same period were \$176K. Expenses were also largely in line with budget. Note that SPED expenses were negative as they reflect a credit from DPS. Travel expenses were incurred due to staff travel to California for training.
- A negative net income for the month and for each month for the rest of the school year is expected in order to reach our full year budgeted net income.
- Discussion of savings account options. Balance of \$644k could be invested into CDs, etc. Discussed benefits of accessibility vs. higher yield.

• Fundraising Committee Report

Recently grated \$7k from "100 Men Who Care" (P Scudo is member). We are still waiting to hear from the Anschutz Fndtn and preparing a 3 yr. grant request for \$360 to Caring for Denver which will go to salaries and therapy for students, school psychologist and staff training. School sign delayed but coming soon.

• Governance Committee Report

COC will volunteered to lead director eval process. Will attend next governance committee mtg. We have two potential new board members.

• Strategic Planning Committee

The committee has completed and is reviewing the feasibility study draft. Also reviewing the Recovery SOP.

• School Leader Report

Kyle Kirby reported. Discussed: School has gained several students recently. Attendance is increasing steadily.

• Executive Director Report

M. Mouton reported ending the school year on a positive note. School is having its first prom which will be well-attended and graduation will be the first full class: 30 kids!
