1.0 COMMENTS

3.0 EXECUTIVE SESSION

In accordance with the Colorado Open Meetings Law (**§24-6-402(4)(f), C.R.S.)**, the board moved into Executive Session to discuss the purchase, sale, or lease of property. The Board entered Executive Session at 5:45pm, and exited Executive Session at 5:59pm.

4.0 ACTION ITEMS

• Approval of the 2020-2021 Revised Budget, Revision Jan. 2021

M. Mouton described the revisions in detail. On the revenue side, this includes a reduction in gifts, and a decrease in PPR due to an increase in FRL count (resulting in ~\$20K revenue loss). On the expense side, this includes increased funds for acoustical control, changes to leasehold improvements (as discussed in executive session), increased funds for equipment (e.g., microscopes), and a reduction in our contingency because the year is half over. The budget yields an overall fund balance of \$343K, which is very close to our original charter target of \$350K. The board discussed the need to look into how this equates to cash-on-hand, and how we stack-up against industry standards.

- Finance Committee Report
 - Review December Financials

C. Stevenson gave the committee report. The finance committee held its first meeting with the new accountant and account manager and is working through that transition. We're eager to start getting our financials in a format that works well for us. The committee reviewed and approved the committee job description and will review our financial policies in March. On monthly financial statements, C. Stevenson addressed one error on the income statement, but noted that there are no real changes or concerns this month.

P. Scudo will be taking-over the fundraising committee since J. Voight resigned. M. Mouton described some pending and potential grant opportunities.

 - Update and discussion of 2020-2021 organizational goals

R. Ksenyak gave the governance committee report, and noted that the committee will be focusing on board member recruitment, with more detailed plans TBD. The board had an in-depth discussion on the annual School Director and Board goals, and worked-through any goals/targets needing revision. Several goals will serve as providing a baseline for goal-setting and revision for next year.
